


CYBER SECURITY AND DATA PROTECTION POLICIES:

DATA MAPPING AND INVENTORY AND CONSENT MECHANISMS: Assist in identifying and cataloging the types of data collected, stored, and processed by a client's organization. Advising on proper methods for obtaining and managing consent for data processing activities.

VENDOR AND THIRD-PARTY DUE DILIGENCE:
