# **Professional Summary:**

Raju completed his 3-years Degree Course in Science faculty (B.Sc.) from the Wilson College (Bombay University) in May, 1981. # Major Matters Handled:

### ACC LIMITED:

- Was involved in the setting up of Joint Ventures to develop Coal Blocks in M.P. and Chattisgarh for ACC's captive requirement – 4 of these with the Madhya Pradesh Mining Corporation through bidding; and 1 in partnership with other entities for development of a West Bengal Coal Block.
- Taking timely and appropriate legal action against Closure Notices, received by the Company's 3 Plants in Eastern Region, to shut mining operations caused by change in the Mineral Concession Rules pursuant to 2 (two) Supreme Court Rulings in Goa Foundation and Common Cause cases, thereby denying "deemed extension' to all mines pending second and subsequent renewals.



- Filing of Appeals in the Competition Appellate Tribunal against CCI Orders directing the Company to deposit a penalty of Rs. 1,100 Crores and obtaining stay on depositing of 10% of the penalty amount.
- Successfully challenging the Computation of Compensation paid to ACC on Cancellation of its Bicharpur Coal Block (upon its being vested in favour of Ultratech Cement as Successful Bidders); and causing appreciable enhancement of such Compensation for the Coal Block Land & Mine Infrastructure.

# **ESSEL GROUP:**

- Negotiation and finalization of 4 separate Share Purchase Agreements for taking over the Radio Trunking business of Motorola Inc in India.

#### **ESSAR GROUP:**

- Successfully claiming a substantial part out of Rs. 80 Crores claimed against ONGC in arbitration, arising out of a project undertaken by Essar Projects for Modification of Water Injection Pipeline Project to increase the fallen levels of crude oil. The matter was extremely advantageous to move in the backdrop of allegations as to convergence of top managements at Essar and ONGC.
- Lead a young legal team in the High Yield Bond Issue Offering (under Rule 144A) for the raising of USD 1,500 Mio by the Essar Group for its Shipping, Power, Steel and Oil businesses.
